On October 30, 2020 Netherlands Helsinki Committee launched an open regional Call for Proposals "Supply Equipment to Counter Effects of the COVID-19 in Closed Institutions" for CSOs in Armenia, Georgia, Moldova, and Ukraine within scope of EU funded "Covid-19 Solidarity Programme 2020-2022."

NHC received 20 applications for this Call. The designated evaluation committee recommended that Helsinki Citizens' Assembly - Vanadzor (HCAV) in Armenia, The Association of Socially Helpless Therapy of Sighnaghi Region-Qedeli Community, Georgian Association Women in Business (GAWB), Alliance for Better Mental Health, Union Partnership for Equal Rights (PER), Centre for Strategic Research and Development of Georgia (CSRDG) in Georgia, Positive Initiative in Moldova, and Ukrainian Psychiatric Association (UPA) and Charitable Organization "Charitable Fund "Help Center "Save Ukraine" in Ukraine may be awarded the project contract values stated in their financial proposal (maximum 5.000EUR). All proposers have been informed about the evaluation results on their proposals for this Call.
