Call for Proposals to Monitor Effects of COVID-19 in Closed Institutions: LOT 2¹ Psychiatric Hospitals in Georgia

Background

The Netherlands Helsinki Committee (NHC) has launched a regional “COVID-19 Solidarity Programme 2020-2022” with the financial support of the European Union² and in partnership with People in Need and AFEW International. NHC cooperates with Human Rights in Mental Health (Federation Global Initiative in Psychiatry, FGIP) to deliver activities of the Programme. This programme will support civil society organisations (CSOs) to respond to the immediate and longer-term impacts of the COVID-19 pandemic in Eastern Partnership countries. The programme is part of a bigger set of activities carried out by a consortium led by People in Need. The overall aim is to enhance the capacities of CSOs to effectively respond to short- and medium-term challenges arising from the Covid-19 pandemic, and to influence longer-term policy reforms that support vulnerable groups and those disproportionately affected by the pandemic.

Persons living in closed institutions (both prisons and other facilities in the criminal justice chain, and places of confinement of persons with a mental health problem) are included in the vulnerable groups covered in this programme. Specific international guidance has been issued on Covid-19 prevention and treatment for these groups. CSO activity is important to monitor and report on whether and how this guidance is transmitted into national regulations and how these are implemented. Also, there is likely to be a need for the provision of advice to stakeholders and authorities on problems they encounter in Covid-19 prevention and treatment.

This call for proposals is soliciting proposals for grants to address these issues in the 2020-2021 period.

Objectives of the Call

NHC and FGIP seek to provide grants to CSOs to monitor the effect of COVID-19 prevention and treatment measures on the conditions of people confined to psychiatric hospitals in Georgia. This includes the full range of relevant issues including (discontinuation of) health care, (lack of) contact with relatives or loved ones, inclusiveness in Covid-19 vaccination programme in the country, and other related basic human rights. In addition to conducting monitoring and providing findings of the monitoring, the objective would also be to provide advice and assistance to stakeholders, including confined persons, personnel, relatives, lawyers, on

problems they encounter in COVID-19 prevention and treatment. The monitoring report may also serve for local policy advocacy purposes to have greater impact on countries prevention mechanisms in closed institutions.

Organisations (or consortia) that already have access to mental health institutions under a National Preventive Mechanism (NPM) of Georgia or that through another agreement with authorities have access to these institutions are invited to submit a proposal. Applicants that do not have a formalized relationship with governmental bodies that provides access to closed institutions need to prove they have a track record of obtaining reliable information based on monitoring and explain in detail how such information will be gathered.

The aim of the proposal should be to facilitate specific attention for COVID-19 related issues in psychiatric hospitals in addition to ongoing work relating to conditions in psychiatric hospitals.

Selected organizations will be provided with documentation about international standards relevant to COVID-19 in mental health institutions, and will have access for questions of methodology to advice from the pool of experts of NHC and FGIP on monitoring of and health care in psychiatric hospitals.

Eligibility

This call for proposals is open to non-profit-making civil society organisations or consortia of non-profit-making civil society organizations with the status of a legal person, established in Georgia. In case of consortia, the main applicant will be responsible for the overall implementation of the action.

All organizations should have a formalized relationship with respective governmental bodies that provides access to psychiatric hospitals and the applicant needs to prove it has a record of working with these institutions.

Applications should provide evidence of the following:

- Registration status as a non-profit organisation registered under national legislation
- At least four years' experience delivering activities in line with the proposed project
- Experience with managing budgets of similar size

Public administration institutions, state agencies, local or regional authorities, political parties or organisations affiliated with political parties are not eligible for this call.

CSOs that applied for the [LOT1](#) within the scope of this project (to monitor the effect of COVID-19 prevention and treatment measures on the conditions of people confined to mental health institutions) are eligible to apply.

Grant amount and duration

NHC and GIP will support CSO's up to **6000 EUR**. Only one applicant will be granted depending on the quality of the applications and respective situation in the country.

Proposed project duration should lie between 9 and 12 months.

NHC and FGIP reserve the right to suggest applicants to adapt or merge proposals.

Ineligible costs

The budget must be in line with the activities described in the application form. The following activities and expenditures are not eligible under this call:

- Infrastructure projects (constructing roads, bridges, buildings, etc.)
- Purchase of land or property
- Political or religious activities
- Environmentally harmful projects
- Retrospective activities (costs related to activities implemented prior to signing the grant agreement)

Eligible costs include all costs necessary to purchase the necessary equipment such as PPE, vaccines, and IT/communication equipment.

Application Process

Applicants must submit the following:

- Annex 1 – Application Form
- Annex 2 – Budget
- Registration certificate of the organization (original with an English translation)
- Statute of the organisation (if possible in English)
- Evidence of track record in similar projects
- CVs of the project team
- If the proposal is submitted by a consortium: an outline of the cooperation process and the division of tasks between individual members in the application form (annex 1).

Applications can be submitted in English or Georgian. All submitted applications must be signed by the head of the applicant organisation, scanned and sent electronically.

Deadline for submission of full applications is **December 19, 2021**. Incomplete or late applications will not be accepted.

Questions will be responded to within 5 working days.

Proposal selection process

Submitted proposals that score 70 points or above according to the selection criteria below, will be evaluate using following criteria:

1	Cost-effective and realistic budget	15
2	Network and proven experience and expertise in monitoring and reporting	30
3	Analysis of risks and mitigation measures	10
4	Capability in providing follow-up in individual cases	20
5	Availability of local/ regional monitors	25
